Part B – Written attestation

SB 1545 Section 1 (9) states "Eligible property shall be assessed and taxed as other property similarly situated is assessed and taxed beginning with the property tax year that immediately succeeds the earliest of:

- The date on which the rebuilt homestead is no longer occupied by the owner as a homestead, except when the owner is required to be absent by reason of health or active military service;
- The date on which the rebuilt homestead is rented to another person for any duration; or
- The date on which the rebuilt homestead is transferred to new ownership."

SB 1545 Section 1 (7)(b) states "For each subsequent property tax year for which the specially assessed value is claimed, the owner of the rebuilt homestead must file an attestation, under penalties for false swearing, that the owner will continue to occupy the rebuilt homestead as the owner's principal dwelling for the entirety of the property tax year."

I (owner) Bert C Mungor Jr + Melody A Mungor (please print) indicate by my signature I will continue to occupy the rebuilt homestead as my principal dwelling for the entirety of the property tax year. As owner of the above-described property, I acknowledge I understand the circumstances that may disqualify the property from special assessment and that I must file an attestation annually to continue the special assessment in the future.
